**AFFIDAVIT**

*Your affiant upon oath states that he/she has reason to believe and does believe that grounds for issuance of an arrest warrant exists and states the following fact on which such belief is founded:*

On 8/22/2022, at approximately 0751 hrs., Officer Matthew Labine responded to 75 Arnold St apartment #1L to investigate a breaking and entering. On arrival, Officer Labine met with the victim identified as William Grover. Grover stated that he was standing in his kitchen area, when his apartment door swung open and a male subject entered. Grover said that he yelled at the male to get out of his apartment and he immediately recognized him as being Mack Blackie. He advised that the male kept yelling for his room mate [REDACTED], asking where his phone was. Grover said that his wife Veronica ran towards Blackie, yelling for him to get out of the apartment. She was then pushed out of the way. Grover said that once Blackie retrieved the cell phone from [REDACTED], he left the apartment. Grover pointed out fresh damage to the apartment screen door, which was documented with photos by Officer Labine. I spoke with Grover's wife Veronica Higbie, she also identified the male as being Mack Blackie. She confirmed that she knows him through his girlfriend [REDACTED]

This Affiant prays that an arrest warrant be issued for Mack Blackie for breaking and entering.
