

Narrative:

On the above date and I was dispatched to graduate the for a possible B&E past. The suspect known as "Black" forced his way into the apartment then fled after damaging the door.

Upon arrival, I met with the caller William Grover. Grover stated that he was standing in his kitchen just before 0800 hours when his unlocked door to his apartment swung open and a male with a hoodie over his head entered. The male was standind in his living room yelling "WHERE MY PHONE". Sis Grover's room mate. Grover stated that he yelled at the male who he recognized as "Black". While inside, Grover's wife, Veronica Higbie, ran toward "Black" yelling at him to get out of the houise and "Black" pushed her. Once gave "Black" a cell phone he left and kicked the door damaging it. He stated "Black" was about 6 ft tall and was wearing a blue jacket. Grover informed me that he has met Black a few times but only in passing because hes always walking down Arnold Street.

was on scene but not cooperative with my investigation and refused to provide a statement or a name. He only confirmed the incident happened and only knew the male as "Black". Veronica was also not on scene.

The screen door was damaged. There was also a scuff or dirt mark on the bottom of the door in the shape of a foot. Grover was adament about pressing charges on "Black" and completed a statement. He informed me if he saw "Black" he could identify him.

A statement from Grover was obtained and photos of the scene were attatched. I listed Mack Blackie as a possible suspect only because I believe that is his nickname. This case will be forwarded to detectives.
