## NARRATIVE

ON MONDAY AUGUST 19TH, 2024 AT APPROXIMATELY 0802 HOURS, I WAS TASKED WITH RESPONDING TO THE CIRCLE-K LOCATED AT 1122 E. INDIAN SCHOOL RD REFERENCE AN ASSAULT CALL. I WAS TASKED WITH LOCATING THE VICTIM/COMPLAINANT LATER IDENTIFIED AS DEREK STEVENS AND CONDUCTING A 1-ON-1 IDENTIFICATION AS WELL AS OBTAINING A INTERVIEW WITH HIM.

I LOCATED DEREK AT THE CIRCLE-K STANDING JUST WEST OF THE MAIN DOORS. DEREK WAS WEARING A GREY T-SHIRT AND GREY SHORTS THAT WERE DIRTY AND HAD WHAT LOOKED LIKE OLD DARK BLOOD STAINS. I ASKED DEREK TO TELL ME WHAT HAPPENED AND THE FOLLOWING IS A SUMMARY OF HIS INTERVIEW. PLEASE REFER TO MY BODY WORN CAMERA FOR THE EXACT VERBIAGE AND STATEMENTS OF DEREK.

DEREK SAID HE HAD JUST GOTTEN A DRINK FROM INSIDE THE LISTED CIRCLE-K AND WALKED OUT TO THE PARKING LOT AND OVER TO AN OLDER UNKNOWN WHITE MALE WHO WAS STANDING WITH HIS BIKE. DEREK SAID A BLACK MALE, LATER IDENTIFIED AS TYRON MCALPIN WALKED UP AND BEGAN TRYING TO TAKE THE BIKE. DEREK SAID HE GRABBED ONTO THE BIKE SEAT AND BIKE FRAME AND TOLD TYRON HE WASN'T GOING TO TAKE THE BIKE. DEREK SAID TYRON THEN PUNCHED HIM WITH A CLOSED FIST IN THE LEFT CHEEK AREA OF HIS FACE. DEREK SAID A SCUFFLE ENSUED AND DEREK WAS ABLE TO BREAK FREE AND GO INTO THE CIRCLE-K. DEREK SAID CIRCLE-K STAFF TOLD HIM TO LEAVE AND HE REFUSED BECAUSE HE WAS INJURED AND AFFRAID TO GO BACK OUTSIDE WHERE TYRON WAS.

DEREK SAID CIRCLE-K STAFF CALLED POLICE AND DEREK MET THEM OUTSIDE WHEN THE ARRIVED. DEREK SAID HE POINTED AT TYRON WHO WAS NOW WALKING AWAY EASTBOUND ON INDIAN SCHOOL RD AT WHICH POINT OFFICERS WENT AFTER TYRON.

I ASKED DEREK IF HE COULD IDENTIFY THE PERSON WHO HIT HIM AND HE SAID YES. I THEN ASKED DEREK TO GET INTO MY PATROL VEHICLE TO WHICH HE COMPLIED AND GOT INTO HE PASSENGER REAR SEAT. I DROVE DEREK OVER TO THE DOLLAR TREE LOCATED AT 1240 E INDIAN SCHOOL RD WHERE OFFICERS AND PHOENIX FIRE PERSONAL WERE ON SCENE. I PULLED MY TAHOE TO THE FRONT OF THE LISTED STORE. TRYON WAS BEING

PLACED ON A AMBULANCE MEDICAL GURNEY APPROXIMATELY 10 FEET FROM US OUT OUR PASSENGER SIDE. TYRON WAS FACING US AS THE MEDICAL STAFF ASSISTED HIM FROM THE GROUND TO THE GURNEY. AT 0811 HOURS, DEREK POSITIVELY IDENTIFIED TYRON AS THE PERSON WHO PUNCHED HIM IN THE FACE WHILE AT THE CIRCLE-K.

DEREK WAS ULTIMATELY REMOVED MY MY PATROL VEHICLE AND PHOTOGRAPHS OF DEREK AND HIS INJURIE WERE TAKEN. DEREK HAD COMPLAINTS OF PAIN ON THE LEFT CHEEK AREA OF HIS FACE AND LEFT BICEP ARM AREA. I COULD SEE THE LEFT SIDE OF DEREK'S FACE WAS CLEARLY SWOLLEN AND MORE PUFFY THEN THE RIGHT SIDE OF HIS FACE. I FURTHER NOTICED A RED MARK ON DEREK'S LEFT BICEP. DEREK REFUSED MEDICAL ATTENTION FOR HIS INJURIES.

I PROVIDED DEREK WITH A BLUE VICTIM RIGHTS CARD COMPLETELY FILLED OUT AND ADVISED DEREK OF THE QR CODE AND WEB-ADDRESS LISTED ON THE CARD. DEREK WAS THEN RELEASED AND HE LEFT WALKING EASTBOUND ON INDIAN SCHOOL RD OUT OF SIGHT.

Narrative Information

NARRATIVE

ON 08/19/24 AT APX 0740 HOURS, I WAS OPERATING AS A SINGLE MAN UNIT IN A FULLY MARKED POLICE VEHICLE, WEARING A FULLY MARKED POLICE UNIFORM, WHEN I RESPONDED TO AN EMERGENCY CALL OF A FIGHT AT THE CIRCLE K, 12TH ST AND INDIAN SCHOOL RD. THE INFORMATION ON THE CALL INDICATED A WHITE MALE IN HIS 20'S, WEARING A GRAY SHIRT AND BLUE SHORTS WAS THE AGGRESSOR IN A FIGHT, AND WAS STILL IN THE STORE. I RESPONDED FROM THE AREA OF 2ND ST AND MCDOWELL RD.

UPON ARRIVAL IN THE AREA AT 0750 HOURS, I FOUND THE LISTED MALE DEREK STEVENS INSIDE THE CIRCLE K AND ESCORTED HIM OUTSIDE, PER THE REQUEST OF THE STORE MANAGER. OUTSIDE, DEREK TOLD ME HE WAS ASSAULTED BY TWO PEOPLE. DEREK HAD SMALL AMOUNTS OF WHAT LOOKED LIKE DRIED BLOOD ON HIS T-SHIRT, WAS SOMEWHAT DISHEVELED IN HIS APPEARANCE, AND WAS TALKING QUICKLY AND EXCITEDLY AS IF HE HAD JUST BEEN IN A FIGHT. DEREK DESCRIBED BEING ASSAULTED AFTER ATTEMPTING TO STOP A BIKE THEFT, AND SAID THAT HE WAS STRUCK MORE THAN ONCE AND COULD NOT FEEL HIS TEETH AS A RESULT OF THE ASSAULT. DEREK SAID HE WENT INSIDE BECAUSE THE GUY(S) WHO ASSAULTED HIM WERE OUTSIDE THE STORE. HE DESCRIBED THE SUSPECT AS A BLACK MALE WEARING ALL BLACK. DEREK THEN SAW A BLACK MALE WALKING ON THE SIDEWALK, SOUTH OF THE STORE, AND SAID "THERE HE IS RIGHT THERE". I ASKED IF THAT WAS THE PERSON WHO ASSAULTED HIM AND HE SAID "RIGHT THERE WITH THE BACKWARDS HAT ON. YEP". DEREK IDENTIFIED A MAN LATER IDENTIFIED AS TYRON MCALPIN. DEREK TOLD ME THAT HE DESIRED PROSECUTION FOR THE ASSAULT.

I AND OFFICER SUE MOVED TO CONTACT TYRON, WHO WAS WALKING AWAY EASTBOUND ON INDIAN SCHOOL RD. THERE WAS HEAVY TRAFFIC AND I MOVED TO 13TH ST TO CONTACT TYRONE. I CONTINUED TO KEEP VISUAL CONTACT WITH TYRON, UNTIL I INTERCEPTED HIM IN THE PARKING LOT OF THE DOLLAR TREE STORE AT 1240 E INDIAN SCHOOL RD. OFFICER SUE AND I WERE BOTH OPERATING FULLY MARKED PHOENIX POLICE VEHICLES WITH TYPICAL POLICE PAINT AND DECAL SCHEME.

AS I TURNED INTO THE PARKING LOT OF THE DOLLAR TREE, OFFICER SUE WAS BEHIND ME, AND I SAW TYRON CHANGE DIRECTION FROM THE SIDEWALK, TO WALKING DIAGONAL TO THE NORTHEAST THROUGH THE PARKING LOT. I THEN DROVE TO CONTACT HIM AND SAW HIS GATE INCREASE IN SPEED. I MOVED TO BLOCK HIS PATH WITH MY VEHICLE, GAVE HIM A LOUD VERBAL ORDER BEFORE I STOPPED MY VEHICLE, "HEY BUDDY, STOP WHERE YOU'RE AT", AND TYRON CHANGED DIRECTION 90 DEGREES WITH A QUICK STEP. SEEING THIS SEQUENCE OF ACTIONS FROM TYRON THAT COMMUNICATED HIS INTENT TO AVOID CONTACT WITH ME, AND HAVING REASON TO CONTACT TYRON AS A SUSPECT OF AN ASSAULT, I DECIDED TO DETAIN HIM. I QUICKLY EXITED MY VEHICLE TO TAKE HOLD OF TYRON'S LEFT ARM, AND HE IMMEDIATELY ENGAGED IN ACTIVE AGGRESSION BY SWINGING PUNCHES AT MY HEAD, BEGINNING WITH HIS LEFT ARM.

THE IMMEDIATE ACTIONS TAKEN BY TYRON UPON MY ATTEMPT TO DETAIN HIM, MADE IT CLEAR TO ME IN THE MOMENT, THAT HE WAS NOT SIMPLY ASSAULTING ME IN ORDER TO GET AWAY, BUT ENGAGING IN ASSAULTS TO CAUSE ME HARM AND INJURY. THIS WAS EVIDENT BY HIS FIGHTING STANCE WITH HIS LEGS PLANTED FOR

STABILITY AND FORCE DELIVERY, HIS HANDS RAISED TO DELIVER TARGETED PUNCHES AT MY FACE/HEAD, AND MULTIPLE SWINGS WITH CLOSED FISTS AT MY HEAD. ALSO EVIDENT WAS HIS ACTIONS TO REACQUIRE HIS FIGHTING STANCE IN THE FIRST 10 SECONDS OF HIS ASSAULTS, IN ORDER TO CONTINUE HIS ATTEMPTS TO DELIVER STRIKES TO MY HEAD. BECAUSE OF THIS VIOLENT BEHAVIOR, I DELIVERED AS MANY CLOSED FIST STRIKES AS I COULD TO TYRON'S HEAD AREA. THIS RESULTED IN AN INJURY TO MY LEFT HAND WHICH CAUSED IMMEDIATE PAIN AND REDUCED FUNCTIONALITY OF MY HAND TO THE POINT THAT WHEN I ATTEMPTED TO GRAB TYRON'S ARMS, I COULD NOT.

AFTER TYRON REACQUIRED HIS FIGHTING STANCE, HE CONTINUED TRYING TO PUNCH ME. I WAS SUCCESSFUL IN GAINING CONTROL OF TRYON'S HEAD AND WITH THE ASSISTANCE OF OFFICER SUE, WE TACKLED HIM TO THE GROUND. ONCE THERE, TYRON ACTIVELY RESISTED BY FORCEFULLY PULLING HIS ARMS AWAY FROM OUR ATTEMPTS TO HANDCUFF HIM. I APPLIED A CROSS FACE CONTROL TECHNIQUE IN ORDER TO TAKE HIS BODY OUT OF ALIGNMENT AND BETTER CONTROL HIS MOVEMENTS AND PHYSICAL RESISTANCE. WHILE UTILIZING THIS CONTROL HOLD, I YELLED AT HIM TO GET HIS HANDS BEHIND HIS BACK. HE DID NOT COMPLY AND CONTINUED ACTIVE RESISTANCE BY USING OPPOSING FORCE TO US WITH HIS ARMS AND LEGS TO PREVENT HANDCUFFING. BECAUSE OF THE INJURY TO MY LEFT HAND AND TYRON'S ATTEMPTS TO GET OUT OF THE HOLD, I LOST CONTROL OF HIS HEAD. GIVEN TYRON'S WILLINGNESS TO ENGAGE IN ACTIVE AGGRESSIVE ASSAULTS ON ME, I HAD REASON TO BELIEVE THAT HE WOULD CONTINUE THOSE ASSAULTS IF HE GOT BACK TO HIS FEET, AND AFTER I LOST MY CONTROL HOLD ON TYRON'S HEAD, I DELIVERED TWO MORE STRIKES TO HIS FACE AREA TO STOP HIM FROM REGAINING HIS ABILITY TO ASSAULT US. THIS GAVE ME TIME TO ACQUIRE MY TASER AND DEPLOY IT.

WHILE TYRON CONTINUED ACTIVE RESISTANCE, AND EVENTUALLY BITING OFFICER SUE, I DEPLOYED BOTH TASER CARTRIDGES INTO TYRON; ONE IN THE RIGHT SHOULDER AND ONE IN THE RIGHT LOWER ABDOMEN. THIS HAD AN IMMEDIATE LOCKUP EFFECT, WHICH GRANTED OFFICER SUE THE ABILITY TO GAIN A BETTER POSITION AND CONTROL HOLD OF TYRON'S LEFT ARM. I GAVE LOUD VERBAL INSTRUCTIONS TO TYRON TO PLACE HIS REMAINING HAND BEHIND HIS BACK, WHICH HE WAS STILL ACTIVELY HOLDING UNDER HIS CHEST. HE DID NOT COMPLY, AND I DELIVERED ANOTHER TASER CYCLE, AGAIN COMMANDING HIM TO PUT HIS HAND BEHIND HIS BACK. NEAR THE END OF THE SECOND CYCLE, I ATTEMPTED TO PULL TYRON'S RIGHT ARM OUT FROM UNDER HIS CHEST WITH MY LEFT HAND, BUT THE INJURY TO MY LEFT HAND WAS NOW MANIFESTING WITH SHARP PAIN AND THE INABILITY TO GRASP TYRON'S ARM. BECAUSE THIS INJURY WAS GOING TO COMPROMISE MY ABILITY TO DEFEND MYSELF AND PARTNER OFFICER, AND I HAD REASON TO BELIEVE THAT TYRON WOULD CONTINUE TO ASSAULT US IF HE WAS NOT CONTROLLED, I DELIVERING TASER CYCLES UNTIL TYRON GAVE UP HIS RIGHT ARM. BETWEEN ALL THESE CYCLES, I GAVE TYRON TIME TO COMPLY WITH COMMANDS, AND WATCHED FOR COMPLIANCE OR CHANGE IN BEHAVIOR. WHEN HE DID NOT COMPLY WITH COMMANDS, I DECIDED TO APPLY ADDITIONAL TASER CYCLES UNTIL COMPLIANCE WAS GAINED BY TYRON CHOOSING TO PUT HIS RIGHT ARM BEHIND HIS BACK. FOLLOWING THIS, WE WERE ABLE TO SUCCESSFULLY HANDCUFF TYRON, AND I REQUESTED THE FIRE DEPT TO RESPOND AND ASSESS TYRON.

AFTER THIS, I SEARCHED TYRON AND REMOVED PROPERTY FROM HIS PERSON WHICH INCLUDED CASH, A PHONE, KEYS, AND A BELT. I ALSO FOUND TWO EARBUDS THAT HE WAS WEARING AT THE TIME OF CONTACT. I WAS LATER ASSESSED FOR INJURY AND TRANSPORTED TO BANNER UNIVERSITY HOSPITAL WHERE I WAS TREATED. THIS CONCLUDED BY INVOLVEMENT IN THIS INCIDENT.

ON 8/19/2024, AT APPROXIMATELY 0757 HOURS, I WAS WORKING AS A SINGLE-MAN PATROL UNIT IN A FULLY MARKED PATROL VEHICLE WHEN I HEARD OFFICER HARRIS #8275 CLEAR OVER THE RADIO THAT HE NEEDED THE IMMEDIATE RESPONSE OF ADDITIONAL OFFICERS TO HIS CALL FOR SERVICE AT THE DOLLAR TREE, LOCATED AT 1240 E INDIAN SCHOOL RD. WHILE ENROUTE, OFFICER HARRIS ADVISED THERE WAS AN AGGRAVATED ASSAULT ON A PEACE OFFICER, THAT THERE WAS A TASER DEPLOYMENT AND THAT THE SUBJECT WAS NOW DETAINED.

UPON ARRIVAL, AT APPROXIMATELY 0802 HOURS, I PULLED INTO THE DOLLAR TREE PARKING LOT AND OBSERVED A BLACK MALE WAS HANDS CUFFED TO THE REAR AND LAYING ON HIS SIDE IN THE PARKING LOT WHILE OFFICER ACOSTA #9818 STOOD BY WITH HIM. I OBSERVED OFFICER SUE #11787 HAD AN INJURY TO HIS RIGHT WRIST AREA WHICH HE ADVISED WAS A BITE MARK. I ALSO OBSERVED THAT ONE OF OFFICER HARRIS' HANDS HAD BEGAN TO SWELL.

PHOENIX FIRE DEPARTMENT ENGINE 61 (FIRE INC# 24-359119, C-SHIFT, CAPTAIN COOK) RESPONDED TO THE SCENE TO PROVIDE MEDICAL ATTENTION TO THE MALE SUBJECT, OFFICER HARRIS, AND OFFICER SUE. PHOENIX FIRE RESCUE 9 RESPONDED AND TRANSPORTED THE MALE SUBJECT TO ST. JOSEPH'S HOSPITAL FOR PRECAUTIONARY MEASURES.

I WAS THEN INSTRUCTED TO CONDUCT AN INTERVIEW WITH A FEMALE ON SCENE THAT IDENTIFIED HERSELF AS THE WIFE OF THE MALE SUBJECT. I CONTACTED THE FEMALE WHO IDENTIFIED HERSELF AS JESSICA ULASZEK AND WAS ADVISED OF THE FOLLOWING INFORMATION.

JESSICA STATED THAT HER HUSBAND, TYRONE, LEFT FROM THEIR RESIDENCE TO GO TO THE CIRCLE K AROUND 0657 HOURS WHILE SHE REMAINED AT HOME. JESSICA ADVISED SHE LATER REALIZED THAT SHE HAD TWO MISSED FACETIME CALLS FROM TYRONE AT 0739 HOURS AND 0740 HOURS. JESSICA EXPLAINED THAT TYRONE IS DEAF, SO HE WILL FACETIME HER WHILE HE IS WALKING SOMEONE AND FACE THE CAMERA AWAY FROM HIM SO SHE CAN HEAR HIS SURROUNDINGS.

JESSICA ADVISED SHE RETURNED TYRONE'S FACETIME CALL AT 0744 HOURS. WHEN TYRONE ANSWERED THE CALL, JESSICA STATED HE IMMEDIATELY TURNED THE CAMERA AWAY FROM HIM AND JESSICA COULD SEE THERE WAS A MALE RAISING HIS FISTS UP TO TYRONE LIKE HE WAS GETTING INTO A FIGHTING STANCE. JESSICA DESCRIBED THE SUBJECT WITH HIS FISTS UP AS A WHITE MALE WITH BLACK HAIR, WEARING A GRAY SHIRT. ACCORDING TO JESSICA, THE MALE WAS TAKING THIS FIGHTING STANCE TOWARD SEVERAL PEOPLE IN THE CIRCLE K, INCLUDING EMPLOYEES.

JESSICA ADVISED SHE THEN HEARD THE CIRCLE K MANAGER TELL TYRONE TO LEAVE SO THAT HE DID NOT GET INTO TROUBLE. I ASKED JESSICA WHAT KIND OF TROUBLE TYRONE WOULD HAVE BEEN IN AND SHE EXPLAINED THAT TYRONE FREQUENTS THIS CIRCLE K LOCATION WHERE THE EMPLOYEES ARE FAMILIAR WITH HIM AND WATCH OUT FOR HIM. JESSICA STATED TYRONE LEFT AND BEGAN WALKING TOWARD E INDIAN SCHOOL RD, BUT SHE TOLD HIM TO COME STRAIGHT BACK HOME.

THIS SUPPLEMENT IS BEING GENERATED TO DOCUMENT MY INVOLVEMENT WITH THE AGGRAVATED ASSAULT THAT OCCURRED AT 1122 EAST INDIAN SCHOOL ROAD ON 08/19/2024.

ON 08/19/2024 WHILE OPERATING AS A SOLO PATROL OFFICER IN A FULLY MARKED CITY OF PHOENIX POLICE TAHOE, I RESPONDED TO THE CIRCLE K STORE LOCATED AT 1122 EAST INDIAN SCHOOL ROAD UPON THE REQUEST OF SERGEANT HUNT #9027 AT APPROXIMATELY 1018 HOURS. I WAS INSTRUCTED TO CONTACT STORE STAFF ABOUT THE FIGHT THAT OCCURRED PRIOR TO POLICE ARRIVING.

I WAS ABLE TO CONTACT THE STORE MANAGER ARACELI LOPEZ. I ASKED HER WHAT HAPPENED AND SHE TOLD ME THE FOLLOWING. THE FOLLOWING IS A SUMMARY OF WHAT SHE TOLD ME AND IS NOT A VERBATIM TRANSCRIPT.

IT WAS LEARNED FROM HER SHE ARRIVED AT THE STORE AROUND 5:30 AM. SHE TOLD ME WHEN SHE ARRIVED THE WHITE MALE SUBJECT AND BLACK MALE SUBJECT WERE AT THE FRONT DOOR ALONG WITH ANOTHER MALE.

SHE FURTHER SAID THE WHITE MALE TOLD HER HE NEEDED THE SECURITY CAMERA FOOTAGE BECAUSE HE HAD BEEN ASSAULTED LAST NIGHT. ARACELI TOLD HIM HE WOULD NEED TO CALL THE POLICE AND ALSO TOLD HIM TO LEAVE.

IT WAS LATER LEARNED THE WHITE MALE WAS IDENTIFIED AS DEREK STEVENS AND THE BLACK MALE WAS IDENTIFIED AS TYRON MCALPIN.

ARACELI TOLD ME SHE THEN WENT INTO THE STORE. SHE LATER TOLD ME THE WHITE MALE ENTERED THE STORE AGAIN (DEREK STEVENS) AT AROUND 7 AM. SHE TOLD ME HE WALKED TO THE COFFEE AREA AND DROPPED TO THE FLOOR AND LAID DOWN AND SAID HE WAS DIZZY. ARACELI TOLD HIM HE NEEDED TO LEAVE THE STORE AGAIN.

SHE FURTHER TOLD ME THE BLACK MALE (TRYON MCALPIN) WAS TRYING TO GET THE WHITE MALE OUT OF THE STORE.

ARACELI TOLD ME THE WHITE MALE (DEREK STEVENS) WOULD NOT LEAVE THE STORE.

SHE LATER TOLD ME THE BLACK MALE LEFT THE STORE AND WHITE MALE WAS STILL INSIDE. DURING THE COURSE OF THIS CALL, ARACELI ATTEMPTED TO GET THE STORE SECURITY CAMERA FOOTAGE FOR ME TO VIEW; WE WERE ATTEMPTING TO VIEW THE FOOTAGE BUT IT WAS DIFFICULT FOR HER AND FOR MYSELF TO OPERATE THE SECURITY CAMERAS.

I WAS ABLE TO BRIEFLY VIEW A SMALL PORTION OF THE STORE VIDEO. ARACELI WAS ABLE TO SHOW ME THE STORE SECURITY CAMERA FOOTAGE WHEN SHE ARRIVED AT AROUND 5:30 AM. IT SHOWED HER WALKING THROUGH THE FRONT DOOR AND CONTACTING THE TWO WHITE MALES AND ONE BLACK MALE NEAR THE FRONT DOOR. SHE TOLD ME THE WHITE MALE, (DEREK) SAID HE WANTED THE SECURITY CAMERA FOOTAGE BECAUSE HE HAD BEEN ASSAULTED. I COULD SEE HIM SPEAKING WITH HER. I NOTICED IT APPEARED HE HAD BLOOD ON HIS TEE-SHIRT.

THE BLACK MALE WAS AT THE DOOR AT THIS TIME. THE SECURITY CAMERA FOOTAGE GAVE NO INDICATION AT THIS TIME OF A FIGHT.

I WAS ALSO SHOWN A STORE SURVEILLANCE VIDEO WHICH SHOWS DEREK STEVENS AND TYRON INSIDE THE STORE. I COULD SEE DEREK IN A FIGHTING STANCE BUT COULD NOT SEE TRYON SO WE HAD TO CHANGE CAMERAS. I COULD ONLY SEE THE LOWER PORTION OF A SUBJECT'S LEGS WHICH WERE MOVING LIKE HE WAS TRYING TO AVOID DEREK. I COULD NOT SEE ANY ONE BEING HIT AT THIS TIME.

WHILE FOLLOWING OFFICER HARRIS WHO WAS DRIVING HIS OWN POLICE VEHICLE I TURNED INTO THE DOLLAR TREE PARKING LOT LOCATED AT 1240 E INDIAN SCHOOL ROAD. I DROVE NORTH THROUGH THE PARKING LOT TO CUT OFF THE SUSPECT'S DIRECTION OF TRAVEL IN CASE HE WERE TO RUN NORTHBOUND PAST OFFICER HARRIS.

\*\*\*RESPONSE TO RESISTANCE\*\*\*

AS I WAS PUTTING MY POLICE TAHOE INTO PARK I OBSERVED THE SUSPECT SWING AT OFFICER HARRIS WITH HIS RIGHT FIST. I WAS APPROXIMATELY TWENTY YARDS FROM OFFICER HARRIS AND THE SUSPECT. I RAN OVER TO OFFICER HARRIS AND THE SUSPECT AND I HOOKED MY RIGHT HAND AROUND THE BACK OF THE SUSPECTS HEAD, AND WARPPED MY LEFT ARM AROUND THE SUSPECTS BACK AND FORCED HIM TO THE GROUND. DURING THE STRUGGLE, THE SUSPECT LANDED IN A SEATED POSITION AND I PUSHED HIM ONTO HIS STOMACH TO WHICH BOTH OF HIS ARMS WERE UNDER HIS TORSO. THE SUSPECT BEGAN TO USE HIS ARMS TO PUSH HIMSELF UP OFF THE GROUND RESISTING OUR EFFORTS TO APPREHEND HIM. MY LEFT FOREARM WAS TRAPPED UNDER HIS HEAD AND DUE TO THE FACT THE SUSPECT ALREADY ASSAULTED OFFICER HARRIS, AND REISTING OUR EFFORTS TO APPREHEND HIM, I BEGAN TO STRIKE THE SUSPECT IN THE BACK OF THE HEAD WITH A CLOSED RIGHT FIST APPROXIMATELY FOUR TIMES IN ORDER TO GAIN COMPLIANCE. I REACHED UNDER THE SUSPECTS HEAD TO GRAB HIS LEFT WRITS TO BRING IT BACK TO HIS LEFT SIDE AND TO PUT BEHIND HIS BACK.

WHILE I WAS GRABBING ONTO HIS RIGHT WRIST WITH MY RIGHT HAND THE SUSPECT COMMITTED AGGRAVATED ASSAULT BY PUTTING HIS MOUTH ON THE BACK OF MY RIGHT HAND AND CLENCHING DOWN WITH HIS TEETH. I FELT A SHARP PAIN, AND OBSERVED THE BITE MARK ON THE TOP OF MY RIGHT HAND AND OBSERVED A SMALL AMOUNT OF BLOOD. DUE TO THE SUSPECT'S VIOLENT ACTIONS, I STRUCK THE SUSPECT WITH A CLOSED RIGHT FIST IN THE RIGHT SIDE OF HIS FACE AND THE BACK OF HIS HEAD APPROXIMATELY THREE TIMES TO STOP HIS ACTIONS. I HEARD OFFICER HARRIS TELL ME TO MOVE, AND I LEANED BACK TO CREATE DISTANCE FROM THE SUSPECT WHILE MAINTAINING CONTACT WITH THE SUSPECT. OFFICER HARRIS TASED THE SUSPECT, WHICH CAUSED HIM TO ROLL ONTO HIS BACK. I THEN ROLLED THE SUSPECT BACK ONTO HIS STOMACH BY PUSHING HIS LOWER BACK WITH MY RIGHT HAND AND HIS HEAD WITH MY LEFT HAND. HE WAS TURLTLED UP WITH HIS ARMS

DOWN WHICH TYRON REFUSED. OFFICER HARRIS WALKED UP TO TYRON AND TYRON IMMEDIATELY BEGAN TO WALK AWAY FROM OFFICER HARRIS. ON 08/19/2024 AT 0740 HOURS, MYSELF, OFFICER SUE 11787 AND OFFICER HARRIS 8275 RESPONDED TO THE CIRCLE K LOCATED AT 1122 EAST INDIAN SCHOOL ROAD REFERENCE A FIGHT EMERGENCY RADIO CALL.
