Defendant Commerce Bank requests a change of judge pursuant to Missouri Supreme Court Rule 51.05, and in support thereof states:

1. Missouri Supreme Court Rule 51.05 allows a party to request a change of judge without cause “upon the timely filing of an application.” Rule 51.05(b) requires an application to be filed “within 60 days from service of process or 30 days from the designation of the trial judge, whichever time is longer.”
