Comes now the arresting peace officer HOUSE, who on oath says that, to the best of his/her knowledge and belief, that the Defendant did on the 27 day of MAY, 2021, in Clayton County, Georgia at 6580 HWY 85 (location) and at approximately 1430, did commit the following violations of Georgia Law:

In that said offender did: Turn right from Valley Hill Rd onto Hwy 85 without stopping while the light was red. Lemon gave me his license and while gathering his license I asked him his destination and where he came from. Lemon became irate and refused to answer my question. I asked him for his insurance card and he refused to give it to me. I observed a fixed blade knife on the center console near his hands. I asked Lemon to turn off the car and called for another unit to stand by while I continued my stop. Lemon refused to turn off the vehicle and continued refusing to give me a copy of his insurance card. Lemon then cut communications and refused to talk to me. When another unit arrived I told Lemon to exit the vehicle multiple times or he would be arrested for obstructing the traffic stop. Lemon refused until my Sergeant arrived and told him to exit. Once Lemon exited the vehicle I attempted to detain him in handcuffs due to his hostility. Lemon began physically resisting by pulling his arms away and turning to walk off. I pulled him onto the ground and he fell onto his stomach. In the fall I bruised my knee and gained a small cut to my right hand. Lemon scrapped his elbow and complained that his leg hurt. I placed my knee on top of Lemon's upper back while trying to get his arm out from under him to cuff him. Lemon stated "what is this another killing" and continued to resist arrest. Once he finally rolled onto his stomach I was able to gain control of his arm and place him in handcuffs. During an inventory of the vehicle I located a pickle jar containing drug related objects (some sort of container with a burnt poker) with marijuana residue inside. Lemon was placed in an air conditioned patrol car until he refused treatment by EMS on scene.
