It was on Thursday afternoon when I left my then resident at 2538 Spivey Court looking for a place to rent considering that I didn't hear from my current landlord. I was in route to 605 Voyles Drive in Riverdale GA, as I travel North on Tara Boulevard I made a left turn west on Battle Creek Rd and then made a right turn onto Valley Hill Rd. headed in a Northwest direction it was at the intersection of Valley Hill and Mockingbird that I notice a Clayton County Police vehicle behind me and as I stop at the stop light at Valley Hill Rd. and Lamar Hutcheson Pkwy it was clear to me that I was being profiled, as I proceeded to my destination traveling in a Northwest direction Valley Hill Rd transition to a western direction at a light where the traffic is directed left in a western direction when the light changed and as I turn left the Police vehicle turn left as well but transition over to the right lane my assumption was that the police officer wanted to get a side view of me as I traveled after I made the left turn my GPS system was directing me to make a right turn at the intersection of Valley Hill Rd. and Delta & Camp St, at the light Delta St. take a southern direction and camp St. is headed in a northern direction which meant that I had to make a right turn headed North on Camp St. to make it to my destination When the Police officer merged into the right lane that position my vehicle to the left rear side of his vehicle. I was attempting to get in the right lane it wasn't possible because I was at the rear left side of the Police vehicle and it was another vehicle behind the police vehicle. It would have been possible to make the right turn onto Camp St. had the police officer would have pull off once the light changed when the light changed the police officer sat at the light and didn't proceeded forward which left me holding up the traffic in the left lane, because I didn't want the police officer to harass me for holding up the left lane of traffic, it was clear to me that the police officer had no intention of pulling forward which would allow me to make the right turn as I intended too, so I decided that I would make the block to my destination so I pull

forward to the next light at Valley Hill Rd & Springdale which was green I then proceeded to merge to the right lane which put the police vehicle behind me again and when I made it to Valley Hill Rd. & Hwy 85 and proceeded to make a right turn at a green light and when I made the right turn that is when the police officer turn on his lights to pull me over, I proceeded to make another right turn which put me onto the parking lot of M & S Auto sale used auto dealership on Hwy 85 which had security camera which I'm hoping to obtain video footage for that day...

As Officer J. House approach my vehicle on the right side proceed to ask me a question stating "Do you know why I stopped you?" I responded "No, why did you stop me?" Officer House proceed stating that "the reason that I stopped you is because you ran a red light" my immediate response was no I didn't run a red light and then officer J. House proceeded to ask me for my driver's license and I handed my driver license to him. Officer J. House continued asking question as to where I was going. Officer House never proceeded to write me a ticket for running a red light or checked to see if I was wanted for any outstanding warrants or traffic violations.

The interaction between myself and Officer House should be captured on his body camera audio as well the dash camera from his police vehicle the event surrounding the issue of me running a red light.

It became apparent that officer House wanted to escalate a supposedly traffic violation into something more of an egregious act when he made the statement that, "It seem that I didn't want him (Officer J. House) to be behind me, when I attempted to get behind him at the red light where I wanted to make a right turn to reach my destination.

By Officer House own admission he stated that he thought that I was trying to avoid him from being behind me this should be reflected in the audio of the body camera.

This was the statement that he made and that should be reflected on his body camera audio, I attempted to call my daughter so she can hear the interaction that I was having with Officer House but unfortunate that she didn't answer the phone, I then tried to call a friend to have someone who would have heard an audio account of what was taken place and when no one answered the phone on that attempt I proceeded to call 911 which caught the attention of Officer House and he responded by saying "why are you I calling the police?" That he was the police and some point in time officer turn to me and said why was I making the situation so difficult and I responded by saying to him why is he escalating the situation. My interactions with Officer House should be reflected in the body cam audio.

Officer J. House requested that I step outside of my car, and my response to Officer House was why you said that I ran a red light give me a ticket so I can be on my way, it became clear that Officer House had other intention. Officer House requested that I step outside of my vehicle the second time which I complied with, It was clear that Officer House had called for backup support from another police unit. As I stepped out of my vehicle I was accosted by Officer Valentine which he immediately stated "Get your ass on the ground before I tased your ass "without any provocations from me. Officer Valentine proceeded to wrestled me to the ground with assistance of Officer J. House which resulted in some injuries that I suffered as of the aggressive physical attack that was directed towards me which some pictures was taken by a police unit and documented my injuries Officer J. House proceeded to placed his knee on my neck while I was faced down while bruising my neck and shoulder with his tactics, after a brief struggle I was placed in hand cuffs and after being assisted off of the ground and escorted to the police vehicle Officer Valentine wanted to take the liberty to slam me against the police vehicle with the intent of causing more bodily injury to me and after bracing myself and questioning Officer Valentine insistence of physically trying to injury me.

As a result of this encounter which contribute to my condition of cervical stenosis

The arrogance that I experience from both Officer J. House and Sgt. Valentine that they impose their will and had a total disregard for me as a human being.

I would like to pose a question what act of criminality that I committed to be subjected to this response from law enforcement officers to violate my person without any provocation from me. I then placed under arrest, my vehicle was search without my consent, and I've been drag into a criminal injustice system which is a form of oppression which deny me of my personal freedom.

I want to note that I had \$1,800.00 in my possession when I was arrested and was never given an option to bail myself out of Jail, the final financial cost of this encounter has been documented.

After consulting with an attorney about my arrest trying to understand as to how me allegedly running a red light would land myself in jail for two days I learned that I was arrested for obstructing an officers because of the State of Georgia Law which is advantageous and give an officers way to much discretion to make an arrest.

It is because of these type of Laws that contribute to the criminal injustice system and go against the Laws of Probability.

I would like to point out that there were a police unit that documented the injuries that sustain during this incident and I would obtain this information as well.
