IN CONNECTION WITH THIS WAIVER OF FORMAL EXTRADITION PROCEEDINGS, I HAVE BEEN ADVISED THAT I HAVE A RIGHT TO CONSULT WITH AN ATTORNEY BEFORE EXECUTING THIS INSTRUMENT, THAT I HAVE A RIGHT TO HAVE A WARRANT OF EXTRADITION ISSUED AGAINST ME BY THE GOVERNOR OF THIS STATE AND SERVED UPON ME, THAT I HAVE A RIGHT TO OBTAIN A WRIT OF HABEAS CORPUS AND THEREBY CHALLENGE ANY SUCH WARRANT OF EXTRADITION, AND THAT IF I AM INDIGENT AND CANNOT AFFORD COUNSEL, I HAVE A RIGHT TO AN ATTORNEY APPOINTED TO REPRESENT ME AT NO EXPENSE TO ME.

KNOWING AND UNDERSTANDING THOSE RIGHTS, I DO HEREBY FREELY AND VOLUNTARILY WAIVE ALL OF THEM AND CONSENT TO MY IMMEDIATE RETURN TO Florida.

I understand that if I have local charges, the 14 days for the demanding state to pick me up will begin to run at the time I am released on the local charges.

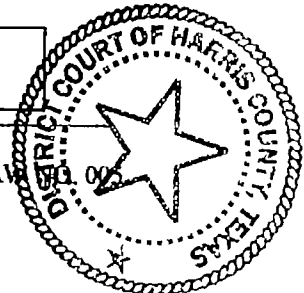
