## Narrative

Subject: Loitering/Prowling

Officer: K. Gracia

Date: 12/05/2023

On 12/05/2023, I was conducting patrol on Altama Avenue.

While traveling South on Altama Avenue, I observed an unknown male, later identified as David Smiley, wearing a tan shirt and black pants waving what appeared to be some type of a stick in the air in front of 72 Altama Avenue. (Cost Kutter Grocery) I advised Officer Ramirez of what I observed. I advised that it was just past midnight and that this person is the only one in the area. The only vehicle in the vicinity of Mr. Smiley was a white RV.

I advised Dispatch that I would be getting out with Mr. Smiley. Upon making contact with Mr. Smiley, I observed a broom in his hand and asked if he works for Cost Kutter Grocery? Mr. Smiley advised he works for DNB Sweepers and that he was contracted to clean the parking lot, the ceiling of the walk way and behind the parking lot. Officer Ramirez asked Mr. Smiley for his identification, He wanted to know why. Officer Ramirez advised Mr. Smiley it was due to loitering/prowling. Mr. Smiley advised he had done nothing wrong, and he was not loitering/prowling. Officer Ramirez again asked Mr. Smiley if he would identify himself, Mr. Smiley advised he had done nothing wrong. Mr. Smiley was then placed under arrest, double locked and checked for fit. Officer Ramirez advised Mr. Smiley he was going to jail for loitering/prowling due to not identifying himself. Mr. Smiley was searched incident to an arrest with negative findings. Mr. Smiley was placed in the back seat of the patrol car seat belted in.

A white female, later identified as [REDACTED], had walked up to Officer Ramirez and I while speaking with Mr. Smiley. I asked [REDACTED] for her name and date of birth. She did not give me her name or date of birth. Ms. [REDACTED] asked why I needed her name and date of birth. I advised her it was because of loitering/prowling. I asked [REDACTED] for her name and date of birth again. [REDACTED] advised she did not understand why I was asking for that. She was again advised she was loitering/prowling. I then placed Ms. [REDACTED] under arrest for loitering/prowling, failing to identify herself. Handcuffs were double locked and checked for fit. While Officer Ramirez was searching the female, [REDACTED] was asked if she had any sharp objects in her pockets. [REDACTED] advised she had an insulin pump and other medical devices on her person. [REDACTED] was un-arrested due to the medical device attached to her and due to her identifying herself.

Mr. Smiley was transported to the Glynn County Detention Center where he was released without incident. The Sheriff's Office was able to identify Mr. Smiley. A warrant will be drafted for Mr. Smiley for loitering/prowling.
