NOTICE OF REMOVAL

Pursuant to 28 U.S.C. §1331, 1441 and 1446, Defendant Chief Jacquelyn Gwinn-Villaroel (“Chief Gwinn-Villaroel”), hereby removes this action styled Johnnie Givens, *et al.* v. Steven Mantle, *et al.*, Jefferson Circuit Court, Commonwealth of Kentucky, Civil Action No. 25-CI-000770, to the United States District Court for the Western District of Kentucky, Louisville Division on the grounds that this Court has federal question subject matter jurisdiction insofar as the allegations set forth in the Complaint assert violations of the Fourth Amendment of the United

States Constitution via 42 U.S.C. §1983. A copy of the Complaint, Summons, and all pleadings of record to date in the State Court is attached hereto as **Exhibit A**.

1. THE NATURE OF THE CASE

This action was filed in the Jefferson Circuit Court, Commonwealth of Kentucky, Case No. 25-CI-000770 on January 31, 2025. Defendant Chief Gwinn-Villaroel was served with the Complaint on February 10, 2025. The Complaint alleges that on or about January 31, 2024, various Defendant police officers responded to a 911 domestic violence call at the house of Plaintiff Johnnie Givens and his disabled adult son, Plaintiff Micah Davis. The Complaint alleges that in the course of the response, various Defendant police officers wrongfully entered Plaintiff Givens's home and took him into custody, and that as a result of the events of the night Plaintiff Davis suffered seizures. Plaintiffs allege that the conduct of the Defendant police officers violated their civil rights under the Fourth Amendment of the United State Constitution, causing them injuries, and have filed their civil action for compensation pursuant to 42 U.S.C. §1983 *et seq.* (See **Exhibit A**). Plaintiffs' Complaint additionally states counts for claims of liability against Defendant Chief Gwinn-Villaroel, the Louisville Metro Police Department, and the Louisville/Jefferson County Metro Government, as well as common law claims for assault and battery, negligence, gross negligence, negligence *per se*, false imprisonment, official misconduct, and malicious prosecution, all arising out of the same set of facts.

II. THE REQUIREMENTS FOR REMOVAL ARE SATISFIED.

A. This Court has Original Federal Question Subject Matter Jurisdiction

This Court has original subject matter jurisdiction of this action under 28 U.S.C. §1331 because Plaintiffs have brought claims pursuant to 42 U.S.C. §1983 alleging violations of their rights under the United States Constitution.

B. This Court has Supplemental Jurisdiction Over All State Law Claims

This Court additionally has supplemental jurisdiction pursuant to 28 U.S.C. §1337 over any and all state or common law claims alleged in Plaintiffs' Complaint, as all of those claims are so related to federal question claims that they form part of the same case or controversy under Article III of the United States Constitution.

C. This Removal is Timely

This Notice of Removal is filed within thirty days after Chief Gwinn-Villaroel was served with Plaintiffs' Complaint and is therefore timely filed as required by 28 U.S.C. §1446(b).

D. Venue in this Court is Proper

The venue of the removed action is proper in the Western District of Kentucky, Louisville Division as the district and division embracing Jefferson County, Kentucky.

E. Consent of Properly Joined and Served Defendants

All other named Defendants in this case, via their counsel, have provided notice of their consent to removal. (See **Exhibit B** – Consent of Co-Defendants).

F. This Notice of Removal Complies With 28 U.S.C. §1446

Defendant Chief Gwinn-Villaroel has complied with 28 U.S.C. §1446(a) and (b). In compliance with 28 U.S.C. §1446(d), copies of this Notice of Removal and written notice hereof are being filed with the clerk of the Jefferson Circuit Court, Commonwealth of Kentucky, Case No. 25-CI-000770, and served on Plaintiffs' counsel, as well as all counsel of record.

IV. CONCLUSION

Defendant Chief Gwinn-Villaroel removes this action from the Jefferson Circuit Court, Commonwealth of Kentucky, Civil Action No. 25-CI-000770 to this Court. Defendant Chief

Gwinn-Villaroel intends no admission of liability by this notice and expressly reserves all defenses, motions and pleas available under the Federal Rules of Civil Procedure.

Come the Plaintiffs, Johnnie Givens and Micah Davis, by and through counsel, and for their Complaint against the above-named Defendants and hereby state as follows:

PRELIMINARY STATEMENT

1. This case presents multiple claims against the Louisville/Jefferson Metro Government (“Metro”) and its law enforcement officers (“Defendant Police Officers”) arising from an incident in which officers for the Louisville Metro Police Department (hereafter “LMPD”) lacked probable cause to arrest Johnnie Givens (“Johnnie”), used excessive force, engaged in police brutality and corruption, excessively charged Johnnie with various crimes, caused bodily injuries to Johnnie and his adult son Micah Davis (“Micah”), caused Johnnie and Micah to incur medical expenses, and violated Plaintiffs’ civil and constitutional rights under the color of law pursuant to 42 USC §1983.

JURISDICTION AND PARTIES

2. Plaintiffs are adult residents of Louisville, Kentucky and resided there at the time of the events that gave rise to this claim.
3. Defendant Police Officers are officers for the LMPD and served as LMPD officers during the events that gave rise to Plaintiffs’ claims. They are named in this lawsuit in their individual and official capacities.
4. Chief Jacquelyn Gwinn-Villaroel (“Chief Gwinn-Villaroel”) was the acting Chief for the LMPD and served as Commissioner at all times relevant to Plaintiffs’ claims. She is named in this lawsuit in her individual and official capacities.
5. The Louisville Metro Police Department (LMPD) is a Kentucky government body that is charged with the duty to provide law enforcement services and protection for the City of Louisville and the Commonwealth of Kentucky.
6. The Defendant, Louisville/Jefferson County Metro Government (“Metro”), at all times mentioned herein, employed, was responsible for the establishment of policies and



practices, either formally or by custom, and was responsible for the employment, training, supervision, and conduct of employees and officers of the LMPD. The conduct, customs, practices, and policies of the Defendant, Metro, were the moving force of the violations of the Plaintiffs' clearly established constitutional rights to be free from unlawful searches and seizures, free from the use of excessive force, and free from violations of state law claims.

7. The facts that give rise to this lawsuit occurred in Jefferson County, Kentucky, and Defendants are otherwise subject to the personal jurisdiction of this Court.
8. The amounts Plaintiffs seek in this lawsuit exceed the minimal jurisdictional amount of this Court, and jurisdiction and venue in this Court are otherwise proper.

STATEMENT OF FACTS

9. On or about January 31, 2024, Plaintiff Johnnie, an African American male and a former law enforcement officer, exercised his legal right to call the police for assistance after being threatened in his own home by his daughter and her boyfriend, who brandished a firearm at him. His residence is located at 4912 Simpson Drive, Louisville, Kentucky 40212.
10. In response to this life-threatening situation, Johnnie, a trained former officer, retrieved his firearm to protect himself and his family while dialing 9-1-1 for help.
11. While Johnnie was actively seeking police intervention, his daughter and her boyfriend fled the premises.
12. Under information and belief, Johnnie's daughter called the police over an hour later from a different location, highlighting the dubious nature of her allegations.

13. Upon arrival at Johnnie's home, Defendant Police Officers found no immediate threat but nonetheless demanded that Johnnie disarm himself, which he did voluntarily in a demonstration of good faith and compliance.
14. Johnnie and his wife, Robin Givens ("Robin"), clearly explained to the Defendant Police Officers that their disabled son, Micah, was in the next room in a hospital bed, suffering from seizures due to a traumatic brain injury sustained in his youth.
15. Despite this crucial information, Defendant Police Officers proceeded to act recklessly, claiming that they had received a call from Johnnie's daughter accusing him of domestic violence—an accusation made long after she had left the premises.
16. Johnnie provided his truthful version of events, refuting the baseless allegations against him.
17. Ignoring Johnnie's clear claim of innocence, the absence of any observable evidence of wrongdoing, and the significant time and distance between the alleged incident and their response, the Defendant Police Officers erroneously cited "Kentucky Law" as a pretext for arresting Johnnie without cause.
18. When Johnnie, attempted to shut his own front door, the Defendant Police Officers unlawfully escalated the situation.
19. Without a warrant, probable cause, or legal justification for a warrantless entry, the Defendant Police Officers violently forced their way into Johnnie's home, kicking the door open and slamming Johnnie onto the ground in front of his wife and disabled son.
20. This excessive and unnecessary use of force resulted in Johnnie sustaining physical injuries, while his son Micah, overstimulated by the chaos and flashing police lights, suffered a seizure.



21. Shockingly, under information and belief, a total of fifteen (15) police officers from LMPD entered the home, compounding the unlawful intrusion and gross abuse of power.
22. After violently arresting Johnnie, Defendant Police Officers continued their intimidation tactics by lingering inside the home, subjecting Robin to menacing stares while she pleaded for them to leave her home in peace.
23. The Defendant Police Officers wrongfully charged Johnnie with Assault 4th Degree – Domestic Violence in Jefferson County, case number 24-M-762, despite having no substantive or credible evidence.
24. Johnnie, now a victim of police misconduct, was transported to the hospital due to the injuries inflicted by the Defendant Police Officers before being booked into Louisville Metro Department of Corrections.
25. In custody, Johnnie was subjected to further mistreatment, placed in solitary confinement for nearly two (2) hours, where he struggled to breathe and was denied his prescription medication, exacerbating his suffering.
26. Ultimately, the criminal charge against Johnnie was dismissed with no stipulation of probable cause on December 2, 2024, further proving the Defendant Police Officers' wrongdoing.
27. The Defendant Police Officers egregiously violated the Plaintiffs' rights by unlawfully entering their home without a warrant, arresting Johnnie without probable cause, and inflicting unnecessary physical and emotional trauma upon the family.
28. The Defendant Police Officers' actions were in clear defiance of legal standards and basic human decency, as they abused their authority to unjustly target Johnnie while failing to protect his rights.

29. Plaintiffs have suffered and continue to suffer severe emotional and physical distress due to the unlawful actions of the Defendant Police Officers.
30. The Defendant Police Officers' misconduct was willful, in bad faith, malicious, and conducted with reckless disregard for Plaintiffs' rights, demonstrating deliberate indifference to their well-being.
31. Given the intentional, reckless, and malicious manner in which the Defendant Police Officers acted against Johnnie and Micah, they are entitled to punitive damages.
32. The Defendant Police Officers' egregious behavior is reflective of a broader pattern of misconduct enabled by Louisville Metro and Chief Conrad, including a failure to train, supervise, discipline, or properly instruct officers regarding civilian rights, lawful stops, arrests, and use of force.
33. The violations committed by the Defendant Police Officers were clearly established as illegal and unconstitutional prior to this incident, rendering them ineligible for qualified immunity.
34. Plaintiffs expressly reserve the right to amend this Complaint upon further discovery, including but not limited to unredacted body camera footage, which will further expose the traumatic nature of this unlawful encounter.

**COUNT I -- DEPRIVATION OF RIGHTS UNDER
THE FOURTH AMENDMENT AND 42 U.S.C. §1983 –
UNREASONABLE SEARCH AND SEIZURE/EXCESSIVE FORCE**

35. Plaintiffs re-allege and incorporate by reference all previous paragraphs as though fully stated herein.
36. That the conduct of the Defendants was subject to 42 U.S.C. §§1983, 1985, 1986, and 1988.



37. The Defendants, acting under color of law, deprived Plaintiff of his substantial rights secured by the United States Constitution and other laws, along with his constitutional right to equal protection of the laws.
38. The aforementioned actions of the Defendant Police Officers, as described in this Complaint, caused Johnnie to be physically injured and restrained and then subjected Johnnie to false and malicious charges that violated Johnnie's civil and constitutional rights as guaranteed under 42 U.S.C. §1983 and the Fourth Amendments to the United States Constitution, including, but not limited to the right to be free from unreasonable searches and seizures of his person and the right to be free from the use of excessive, unreasonable and unjustifiable force.
39. The aforementioned actions and inactions of Defendant Police Officers in condoning, authorizing, directing and/or causing Johnnie to be physically injured and restrained and then subjected to false and malicious charges that violated Johnnie's civil and constitutional rights as guaranteed under 42 U.S.C. §1983 and the Fourth Amendments to the United States Constitution, including, but not limited to the right to be free from unreasonable searches and seizures of his person and the right to be free from the use of excessive, unreasonable and unjustifiable force.
40. The aforementioned Defendants, who were acting under color of law, alone or in concert with one another, caused specific and serious physical and emotional pain and suffering and were 1) excessive and unreasonable, (2) done intentionally, willfully, maliciously, with a deliberate indifference to and/or with a reckless disregard for the natural and probable consequences of their acts and (3) done without lawful justification or reason.

41. As a direct and proximate result of Defendants' wrongful acts and omissions, Johnnie suffered and may suffer in the future substantial and permanent physical and emotional pain and humiliation, attorney fees and medical costs.
42. As a further result of the events alleged herein, Johnnie suffered loss of liberty and other constitutional rights mentioned previously.

**COUNT II -- DEPRIVATION OF RIGHTS UNDER
THE FOURTH AMENDMENT
42 U.S.C. §1983 – FALSE ARREST**

43. Plaintiffs re-allege and incorporate by reference all previous paragraphs as though fully stated herein.
44. Under the Fourth Amendment to the U.S. Constitution, Johnnie has a right to be free from arrest without probable cause and these rights are enforceable under 42 U.S.C. §1983.
45. The Defendant Police Officers had no probable cause to believe that Johnnie was committing or had committed a crime at the time the Defendant Officers placed him under arrest.
46. As a result of his arrest and detention without probable cause by the Defendant Police Officers, Johnnie suffered and may suffer in the future, physical and emotional pain and humiliation, attorney fees, and medical costs.

**COUNT III -- LIABILITY OF CHIEF GWINN-VILLAROEL & HER
AGENTS**

47. Plaintiffs re-allege and incorporate by reference all previous paragraphs as though fully stated herein.
48. At all times relevant to this Complaint, Defendant, Gwinn-Villaroel, had in effect policies, practices and customs that condoned and fostered the unconstitutional conduct



of the police officers.

49. At all times relevant to this Complaint, said Defendant, Gwin-Villaroel, either directly or indirectly, under of color of law, approved or ratified the unlawful, deliberate, malicious, reckless, and wanton conduct of the police officers heretofore described.
50. At all times relevant to this Complaint, said Defendant, Gwin-Villaroel, had in effect policies, practices and customs and usages of encouraging and/or tacitly sanctioning the violation of individual rights, including but not limited to, approving officers to agree to case dismissals as long as probable cause is stipulated, in an effort to shield the police department from civil liability.
51. Said Defendant, Gwin-Villaroel, was negligent in hiring, retaining, monitoring, supervising and/or failing to take remedial actions.
52. Said Defendant, Gwin-Villaroel, inadequately and improperly investigated incidents of police misconduct.
53. Said Defendant, Gwin-Villaroel, failed to enforce policies and procedures and legal requirements.
54. Said Defendant, Gwin-Villaroel, failed to adequately train, supervise and/or discipline his officers, thereby failing to adequately discourage and prevent further constitutional violations.
55. Said Defendant, Gwin-Villaroel, failed to have policies and procedures in place to guard against police misconduct, which was a substantial contributing factor in causing Plaintiffs to suffer damages.
56. The wrongful practices, policies, customs and/or usages complained of herein demonstrated a deliberate indifference on the part of the Defendant, Gwin-Villaroel, to

the constitutional rights of persons within the state and were the direct and proximate cause of the damages, including violations of Plaintiffs' rights alleged herein.

57. Furthermore, Defendant Gwin-Villaroel is vicariously liable for the acts of her officers.

COUNT IV – LIABILITY OF METRO, LMPD, AND THEIR DEFENDANT AGENTS

58. Plaintiffs re-allege and incorporate by reference all previous paragraphs as though fully stated herein.
59. Defendants' acts and/or omissions resulted in the constitutional violations suffered by Plaintiffs, making them liable for the damages suffered by Plaintiffs as a result of the conduct of the Defendant Police Officers.
60. At all times relevant to this Complaint, Defendants, Metro and the LMPD, had in effect policies, practices and customs that condoned and fostered the unconstitutional conduct of officers.
61. At all times relevant to this Complaint, said Defendants, either directly or indirectly, under of color of law, approved or ratified the unlawful, deliberate, malicious, reckless, and wanted conduct of the police officers heretofore described.
62. At all times relevant to this Complaint, said Defendants, had in effect policies, practices and customs and usages of encouraging and/or tacitly sanctioning the violation of and/or retaliation for individual rights, including but not limited to, approving officers to agree to case dismissals if probable cause is stipulated, in an effort to shield the police department from civil liability.
63. Said Defendants were negligent in hiring, retraining, monitoring, supervising and/or failing to take remedial actions.



64. Said Defendants inadequately and improperly investigated incidents of police misconduct.
65. Said Defendants failed to enforce policies and procedures and legal requirements, including, but not limited, initiating a disciplinary action under the LMPD Standard Operating Procedures §5.1, which states “members of the LMPD will not commit any act that constitutes a violation of any of the laws and ordinances applicable in their current respective location.”
66. The Defendants took no disciplinary action against any of the Defendant Police Officers.
67. Said Defendants failed to adequately train, supervise and/or discipline their police officers, thereby failing to adequately discourage and prevent further constitutional violations.
68. Said Defendants failed to have policies and procedures in place to guard against police misconduct, which was a substantial contribution factor in causing Plaintiffs to suffer damages.
69. The wrongful practices, policies, customs and/or usages complained of herein demonstrated a deliberate indifference on the part of the Defendants to the constitutional rights of persons within Metro and were the direct and proximate cause of the damages, including violation of Plaintiffs’ rights alleged herein.
70. Furthermore, Defendants are vicariously liable for the acts of their police officers.

COUNT V- ASSAULT AND BATTERY-COMMON LAW CLAIMS

71. Plaintiffs re-allege and incorporate by reference all previous paragraphs as though fully stated herein.

72. By the conduct and actions described herein, the Defendant Police Officers, committed the torts of assault and battery upon the Plaintiffs Johnnie and Micah.
73. The Defendant Police Officers had physical contact with the Plaintiff Johnnie, which was intentional, unauthorized and grossly offensive.
74. The Defendant Police Officers intentionally placed Plaintiffs in imminent fear of bodily injury.
75. The actions of the Defendant Police Officers were intentional, reckless, unwarranted, nonconsensual and without any just cause or provocations.
76. As a direct and proximate result of the foregoing, Plaintiffs were subjected to physical and emotional pain and humiliation, were deprived of their liberty and was otherwise damaged and injured.

**COUNT VI - NEGLIGENCE, GROSS NEGLIGENCE
AND NEGLIGENCE PER SE**

77. Plaintiffs re-allege and incorporates by reference all previous paragraphs as though fully stated herein.
78. That as a result of the aforementioned conduct, Defendant Police Officers breached their respective duties of care to or in favor of Plaintiffs and were negligent and/or grossly negligent.
79. That pursuant to KRS § 446.070 "(a) person injured by the violation of any statute may recover from the offender such damages he sustained by the reason of the violation although a penalty or forfeiture is imposed for such violation."
80. That the Defendant Police Officers knew or should have known of their obligations to comply with LMPD Standard Operating Procedures that were in place at the time of the incident, including §5.1 - Rules and Conduct, and §9.1 - Use of Force.



81. The Defendant Police Officers knew, or should have known that assault, false imprisonment, and official misconduct are criminal charges codified in the Kentucky Revised Statutes, and by committing these crimes they willfully violated Kentucky Law.
82. That the failure of the Defendant Police Officers to not violate the Kentucky Revised Statutes is unlawful and in violation of LMPD Standard Operating Procedures §5.1, resulting in physical and emotional injuries sustained by the Plaintiffs.
83. The Defendant Police Officers knew or should have known that the acts of assault and battery upon Johnnie constituted excessive force, therefore willfully violating LMPD Standard operating Procedures §9.1, resulting in physical and emotional injuries sustained by the Plaintiffs.
84. But for the Defendant Police Officers violation the Kentucky Revised Statutes and LMPD Standard Operating Procedures, the Plaintiffs would not have suffered the injuries described herein.

COUNT VII - FALSE IMPRISONMENT

85. Plaintiffs re-allege and incorporate by reference all previous paragraphs as though fully stated herein.
86. The Defendant Police Officers restrained Johnnie's person, confined him against his will and deprived him of liberty of movement without his consent.
87. Plaintiff was aware of the confinement and suffered pain and mental anguish as a result.
88. As a proximate and substantial result, Plaintiff has suffered physical and emotional pain and humiliation, was deprived of his liberty and was otherwise damaged and injured.

COUNT VIII - OFFICIAL MISCONDUCT

89. Plaintiffs re-allege and incorporate by reference all previous paragraphs as though fully

stated herein.

90. All Defendants, public servants acting under color of law, intended to injure Plaintiffs and deprive them of their civil rights while knowingly (1) engaged in conduct related to his office and which constituted an unauthorized exercise of his official functions, (2) refrained from performing a duty imposed upon him by law or clearly inherent in the nature of his office and/or (3) violated a statute or lawfully adopted rule or regulation relating to their office.
91. All Defendants' conduct violated K.R.S. §522.020 and caused Plaintiffs to suffer damages.
92. Pursuant to K.R.S. § 446.070, the Plaintiffs are entitled to recover damages from the Defendant for the Defendants' violations of K.R.S. § 522.020.

COUNT IX – MALICIOUS PROSECUTION

93. Plaintiffs re-allege and incorporate by reference all previous paragraphs as though fully stated herein.
94. The Defendant Police Officers individually and collectively, maliciously and intentionally, caused Johnnie to be subject to a wrongful prosecution for the offense of Assault 4th Degree – Domestic Violence.
95. The Defendant Police Officers initiated, continued and procured a criminal proceeding against Johnnie and did so without probable cause to achieve a purpose other than bringing Johnnie to justice.
96. Johnnie has suffered damages because of the criminal proceeding against him including, but not limited to, his attorney fees.

WHEREFORE, Plaintiffs, Johnnie Given and Micah Davis, demand the following relief:



1. Compensatory damages as supported by evidence and determined by a jury;
2. Punitive damages;
3. Attorney fees;
4. Court costs;
5. Leave to amend this Complaint;
6. Pre-judgment and post judgment interest;
7. Trial by jury;
8. Any and all other relief to which the he is properly entitled in law and equity.
