On August 3, 2025, at 11:06 pm, Officer O'Brien and I were dispatched to The Cumberland Oaks Apartments at 100 Mary Powell Drive, [REDACTED] in St. Marys, GA 31558 (Camden County) for a threats call. We responded in Officer O'Brien's marked patrol vehicle without using his emergency lights and siren.

Dispatch informed officers that a female victim was waiting at the Dollar Tree located at 2603 Osborne Road in St. Marys to talk to officers about what was said and done to the female. The female was identified as [REDACTED] through GCIC/NCIC. [REDACTED] informed Officer O'Brien and me that her "baby daddy" threatened to kill her and police officers if she were to call the police. She also mentioned that the male would have a shootout with the police. She then informed us that the male subject grabbed her arm aggressively and that when she was able to free herself, she ran to her vehicle and drove off. [REDACTED] claims she was in fear for her life and that the male subject was holding onto the vehicle's passenger window as she drove away.

[REDACTED] stated she did not know if the male subject had a firearm. All she knew was that she was in fear for her life and did not want to be near the male subject anymore, and that's when she called 911 dispatch. [REDACTED] informed us that the male subject was under the influence of an alcoholic beverage. Sergeant Shaw, Officer O'Brien, and I then drove to the entrance of the Cumberland Oaks Apartments where we waited for Camden County Deputies to assist. Due to the threats made towards law enforcement officers, Sergeant Shaw and I believed that more officers involved would be helpful.

All law enforcement officers were then staged at the base of the E Building in the apartment complex. Officer O'Brien and I were at the door of [REDACTED] while Sergeant Shaw was on the stairwell as cover. I knocked on the door loudly and announced loudly that the St. Marys Police were there. I knocked the same way again, and no one answered. I checked the door to see if it was unlocked, and I noticed the door was deadbolted. [REDACTED] informed us that the male subject did not have a key, so he must have been inside and locked the door from inside. Officer O'Brien then retrieved a ballistic shield from Sergeant Shaw's marked patrol vehicle. [REDACTED] gave us the key to her apartment and permission to enter the residence to see if the male subject was inside.

Once Officer O'Brien received the key, we began to make entry into the apartment. As Officer O'Brien began to push the door open, I was covering him with the ballistic shield, and the door opened from the inside. We were then greeted by the male subject, and I began to give loud verbal commands for the subject to keep his hands visible. He then began to slur his words and walk backwards inside the apartment. He then began to shut the door and reach behind his back with his right hand. I then saw his arm extend towards Officer O'Brien and me. I then heard a gunshot and saw a muzzle flash and returned fire towards the male subject. I shot my firearm approximately six to eight times toward the male subject and fell backwards onto my back. I then got up and proceeded to cover the male subject while Officer O'Brien handcuffed him.

On August 3, 2025 at 11:06 PM, I responded to a call regarding terroristic threats at 100 Mary Powell Drive, [REDACTED] Saint Marys, Georgia 31558 (Camden County). I arrived on scene with Officers Dexter and O'Brien. Before our arrival, we spoke with the complainant, [REDACTED], at the Dollar Tree in Saint Marys. She explained that her boyfriend, Gregory Peter Paige, had been drinking, threatening her, and physically grabbing her. He told her that if she called the police, he would kill her and the police, and mentioned that he possibly had a gun on his person.

[REDACTED] stated that this was her home and she was the only one with a key to the door. She offered to allow us to search the apartment so she could return home.

After leaving the Dollar Tree, we responded to her apartment. I notified Camden Dispatch and requested assistance from the Sheriff's Office due to the seriousness of the threats and limited manpower. Officers from the Saint Marys Police Department and deputies from the Camden County Sheriff's Office arrived on scene. We made our way up the stairs to the apartment. The stairway and balcony area were poorly lit and very dark. Officer Dexter knocked on the door several times, announcing ourselves. Officer O'Brien retrieved a ballistic shield for protection, which Officer Dexter was holding. After several unsuccessful attempts to make contact, I requested Camden Dispatch to call [REDACTED] to return with her key so we could enter the premises and detain Mr. Paige for terrorist threats and simple battery for further investigation. Once [REDACTED] returned with the key, Officer O'Brien unlocked and opened the door.

When the door opened, Mr. Paige was standing in the living room doorway, which was also poorly lit. He was instructed to come out with his hands up and to turn around. He failed to comply and stated he did not have a gun. He was given several more instructions to turn around and put his hands behind his back, but he refused, saying, "No, ya'll fixin' to kill me." He was told that was not the case. At that point, officers attempted to take Mr. Paige into custody. He lunged back away from us, drew his right hand from behind his back, and pointed it at us. Officers Dexter and O'Brien, who were positioned in front of me, discharged their duty weapons, firing at

Mr. Paige.

As I was going down the stairs to take cover, assuming Officers Dexter and O'Brien were also retreating for safety, I notified dispatch of shots fired. Once I heard the shooting stop, I returned upstairs and found both Officers Dexter and O'Brien lying on the floor. We proceeded into the living room where Mr. Paige was lying on the floor with a gunshot wound to his stomach. He was handcuffed, and CPR was administered along with the use of an AED for life-saving measures. Shortly after, paramedics arrived and took over the life-saving efforts, then transported Mr. Paige to Southeast Regional Medical Center, Camden Campus, located at 2000 Dan Proctor Dr, Saint Marys, Georgia (Camden County).
