Additional Information

On 02/09/24, at approximately 2100, I observed a dark colored Nissan Altima (FL 83DUND) traveling north on Canal St. The vehicle failed to stop for the posted stop sign at the intersection of 13th St. W. and Canal St. till it was in the middle of the intersection. The vehicle then turned west onto 13th St. W. as I made a u-turn to conduct a traffic stop. The vehicle then failed to

stop at the posted stop sign at 13th St. W. and Division St. as it turned north onto Division St.

I activated my emergency lights to conduct a traffic stop on the vehicle. The vehicle traveled for a short distance until it came to a stop in the middle of the lane of travel.

I made contact with the driver and sole occupant, Dwon Ellis, and asked for his driver's license. I then informed Mr. Ellis of the reason for the stop. I could smell the odor of burnt marijuana coming from the vehicle while speaking with Mr. Ellis.

A search of the database revealed that Mr. Ellis' license was suspended on 03/16/2023. I informed Mr. Ellis that his license was suspended and asked him to step out of the vehicle because he did not have a valid driver's license. I asked Mr. Ellis if he had a medical marijuana card and he informed me that he does not smoke marijuana and does not know what hemp products are.

I asked Mr. Ellis to face the vehicle in order to search his person and Mr. Ellis began to actively physically resist by turning his body. Ofc. T. Murphy #80683 and I then placed both of Mr. Ellis' arms behind his back as he continued to resist by tensing his arms and pulling away from me. Once in handcuffs, I again began to search Mr. Ellis who continued to resist by turning his body toward us and attempting to press his body away from the vehicle.

Mr. Ellis was placed under arrest and transported to the PDF.

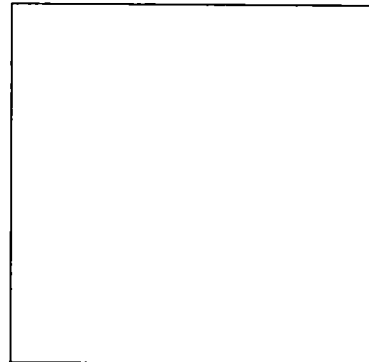
