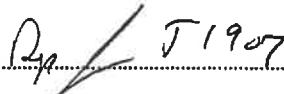

A continued to walk away and refused to remove mask. A was subsequently arrested for the mask charge at issue here. During his first interactions with leo, a refused to provide his identity. A was not compliant with officers and allegedly took steps to avoid being arrested and, later, to avoid being place in the patrol car. 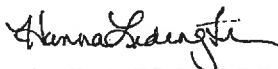
