Before Me, the undersigned authority personally appeared Kristen Whitston 2595 who being duly sworn, alleges, on the information and belief, that on the 8 day of SEPTEMBER, 2025, in Marion County, Florida, the defendant did:

UNLAWFULLY AND KNOWINGLY COMMIT THE OFFENSES OF OPEN CONTAINER CONSUMPTION
ALCOHOLIC BEVERAGE, RESISTING WITH VIOLENCE AND BATTERY ON LEO, TO WIT;


On 9-8-25 I responded to Sam's Big Apple 1943 W SR 40, in reference to a black male wearing a white t-shirt and black shorts, previously trespassed being out front of the business. The business was further advising he stole a gallon of milk and a can of beer. I observed Rodney Harmon standing on the front porch of the business. He matched the description. He had a gallon of milk on the ground next to him and upon seeing me he opened a can of beer (Schlitz 16 oz). He began to drink the beer. I approached him and attempted to remove the beer from his hand. He grabbed my wrist and advised he would "put a mark on me", while pulling away and bowing up his chest. Harmon raised his arm with the beer and spilled it all over the officers. Officer Ower arrived and took him into custody, taking him to the ground due to resisting our efforts to arrest him.

While trying to get him to the vehicle he was continuously using his legs to wrap around this officer causing this officer to fall to the ground. After getting Harmon in the vehicle, I called for a supervisor and an ambulance to check Harmon's vitals. Harmon refused any medical attention.

I made contact with employee Msaal Dejesus with the business. He advised the business did not wish to pursue any charges on the theft or trespass. Harmon was trespassed from the business 11-25-18.


I transported Harmon to jail.
