Additional Information

On 5/9/2026, I observed the listed vehicle driving Eastbound on 103rd St. without any taillights illuminated. I initiated a traffic stop on the vehicle at 7200 Block of 103rd St. by activating my emergency lights. The vehicle then pulled into a Sunoco gas station (7206 103rd St.) and came to a stop.

I approached the driver's side window and was met with a closed window. I knocked on the window, and the driver cracked the window approximately 1 inch. I asked the driver (Tiara Young, Suspect) to roll it down all the way and she stated she did not need to. I advised the suspect the reason for the stop, and she responded by turning on her taillights and staring at me. I asked for her driver's license and she asked why. I advised her because she was committing a traffic infraction and again asked for her license. The suspect began to search through several different handbags and wallets but never produced her license. Due to the suspect having only cracked the window and barely being able to hear her, I asked her to step out of the vehicle. The driver asked why, and I told her so we could talk. She rolled the window down again and said we were talking. I again told her to step out of the vehicle, and she again asked why. I informed her because I was giving her a lawful order, to which she stated it was not a lawful order. The driver continued to argue and would not exit the vehicle.

Once I requested an additional Officer to respond, the suspect finally exited the vehicle. I again asked for her information, which she continued to not provide. Once Ofc. Eddy #82403 arrived on scene, she finally provided her first and last name but would not give a date of birth. The suspect then attempted to re-enter the vehicle, so I grabbed her arm and told her she was under arrest.

The suspect immediately attempted to pull away from both me and Ofc. Eddy and would not comply with our orders. The suspect continued to pull away and attempt to escape our control. While she continued to actively physically resist, I delivered a single knee strike to the suspect's face. The suspect then fell to the ground and continued to resist our efforts to handcuff her. We were eventually able to handcuff her, and I immediately requested JFRD to respond for the suspect (Run #65410, R31).

PIC Hars #81380 responded to the scene.

JFRD medically cleared the suspect.

The suspect received citations for driving without taillights and failing to produce her driver's license.

The suspect was transported to the PTFD without further incident.
