


#10451 AND I, WHO WERE OPERATING AS A TWO-MAN UNIT, WERE BEHIND SGT. AGUILERAS VEHICLE AND ALSO ACTIVATED OUR EMERGENCY EQUIPMENT, AND OBSERVED THE DEFENDANT FLEE (CITATION AMLMEHE).

I MAINTAINED VISUAL SIGHT OF THE DEFENDANT'S VEHICLE WHILE HE FLED AND OBSERVED THE DEFENDANT COMMIT SEVERAL TRAFFIC INFRACTIONS WITH WILLFUL AND WANTON DISREGARD FOR THE SAFETY OF PERSONS AND PROPERTY (CITATION AMLMESE).

ULTIMATELY, THE DEFENDANT CAME TO A STOP ON THE I-95 NORTHBOUND GOLDEN GLADES INTERCHANGE TO THE FLORIDA TURNPIKE. DET. L. MUNIZ #7498 AND DET. T. BELLE #7210 APPROACHED THE DEFENDANT'S VEHICLE AND OBSERVED THE DEFENDANT MAKING AN OVERT REACHING MOVEMENT TOWARD THE PASSENGER SIDE SEAT, APPEARING TO ATTEMPT TO CONCEAL AN OBJECT. 

A P/C SEARCH OF THE VEHICLE REVEALED THAT THE OBJECT THE DEFENDANT WAS OBSERVED MANIPULATING WAS AN OPEN AND UNSECURED SATCHEL CONTAINING A GLOCK 26, 9MM, HANDGUN, LOADED WITH 13 ROUNDS OF LIVE AMMUNITION, INCLUDING ONE CHAMBERED ROUND, UNSECURED OR ENCASED AND READILY ACCESSIBLE FOR IMMEDIATE USE BY THE DEFENDANT.




