MOTOR VEHICLE THEFT**Narrative**

On August 14 at approximately 1315 Hours, I was dispatched to the Hyatt Hotel at 2 W Bay St regarding an auto theft.

Upon my arrival, I spoke with the victim, Ms. Sabrina Preston, who was the driver of a gray 2026 BMW XS XD401. She informed me that she was about to head home to South Carolina when she went downstairs to the lobby to retrieve her loaner vehicle from the dealership. The security guard told her the vehicle had not been in the establishment since approximately 00:30 hours.

Security informed me that the same suspect who had stolen the white Audi was involved in another incident reported to 911 earlier. They told me that this individual arrived at the hotel around 00:30 the night before. This morning, he came into the lobby, then returned to the Audi to grab his belongings. He gave the valet a ticket number for a BMW, claiming he had multiple vehicles at the hotel and that he plays professional basketball. They also advised me that valet tickets are specific to each vehicle and are different for every car. Security had video footage of the suspect giving the valet ticket to the valet staff and taking the car.

Ms. Preston contacted the dealership to track the vehicle, and the last known location, as of today at 12:58 Hours, was 2108 North Ocean Blvd, Myrtle Beach. I called the Myrtle Beach Police Department to report the incident and provided the vehicle description and last known location.

I submitted a request to have the vehicle entered in NCIC/GCIC as a stolen vehicle. I provided Ms. Preston with a CRN card and instructed her on how to obtain a copy of the record.

My BWC was active.
