On 07/19/26 at approximately 0124 hours, I responded to 3479 Shiloh Rd. Hampstead, MD 21074, for the report of harassment which was found to be an assault.

The Carroll County Emergency Communications Center [ECC] advised, "someone threatened to shoot the caller". The caller, [REDACTED] advised the suspect to be "Raqim Warfield [sic]", and described him to be a 19 year old black male approximately 5'9 with rough hair and a beard. The caller stated the suspect left the scene in a gray mazda SUV, and was armed with a shotgun. An allied agency familiar with Warfield provided ECC with MD 1GP1395 via radio. ECC conducted a search of the provided vehicle registration, and yielded Rakim Kordae Warfield with a soundex of MD10274026255.

I arrived on scene at approximately 0148 hours.

I observed a large party of 25 or more individuals taking place.

I contacted victim, [REDACTED] in the driveway. [REDACTED] explained, when he began assaulting an unknown subject in the garage of the residence, Rakim Kordae Warfield struck him from behind [REDACTED] then placed Warfield in a headlock before releasing him and shaking hands before the two separated. Warfield briefly left the party before returning with a shotgun and pointing it at [REDACTED] in the driveway from less than 10 feet away.

I contacted victim/complainant, [REDACTED] in the driveway. [REDACTED] explained, after "punching" Rakim during the above assault, Warfield briefly separated. before retrieved a shotgun and pointed it at [REDACTED] in the driveway from less than 10 feet away.

I conducted an NCIC search of "MD10274026255", which yielded a photograph for Warfield. When questioned, [REDACTED] positively identified Warfield to be the subject who assaulted him and pointed the firearm, with an 11/10 degree of confidence. [REDACTED] believed the photograph was that of Warfield, with a degree of confidence of 6/10.

Several witnesses completed signed statements confirming they observed Warfield point a firearm at [REDACTED] while wearing a ski mask.
